## INSTRUCTIONS FOR ONLINE BID SUBMISSION

This tender document has been published on the Tender Wizard e-Tender portal [www.tenderwizard.com/etenders](http://www.tenderwizard.com/etenders) for inviting the tenders from eligible Suppliers/Vendors. The bidders are required to submit softcopies of their bids electronically on the Tender Wizard portal, using valid Digital Signature Certificates (DSC). The instructions given below are meant to assist the bidders in registering on the Tender Wizard portal, prepare their bids in accordance with the requirements and submitting their bids online on the Tender Wizard portal.

### REGISTRATION

1. Bidders who have already obtained valid user ID and password from Tender Wizard, need not obtain fresh user ID and password for the purpose of participation in the present tender.
2. For New vendor registration, bidders are required to click "**Register Me**" in the home page of [Tender Wizard](http://www.tenderwizard.com) and fill up the vendor registration form.
3. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (class 3 certificates with signing key usage) issued by any certifying authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.) with their profile. Only one valid DSC should be registered by a bidder.
4. As part of the enrolment process, the bidders will be required to choose a unique user name and assign a password for their accounts.
5. Bidders are advised to register their valid e-mail address and mobile number as well. These would be used for any communication from the Tender Wizard.
6. To activate, vendors can pay the Registration/Renewal fee of Rs. 2360/-through e-Payment using Debit/Credit/Net-banking.
7. Bidder then logs into the site through the secured log-in by entering their user ID / password and the password of the DSC / eToken.



## SEARCHING FOR TENDER DOCUMENTS

Bidders can search for the tenders upon clicking “Tender Free View” under “E-Tenders” menu and choosing “K S Rangasamy College of Technology” in the Department field.

## PREPARATION OF BIDS

1. Bidder should take into account any corrigendum published on the tender document before submitting their bids.
2. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bids. Any deviations from these may lead to rejection of the bids.
3. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS formats. Bid documents may be scanned with 100 dpi with color / black & white option.
4. The price bid format and PQR Excel sheet in PDF format is given for ready reference only.
5. The price bid format in excel sheet and PQR excel sheet (in soft not in PDF) may also be downloaded from e-tender website after uploading the details of requisite tender fee/ DD along with scanned copy of the tender fee/DD.
6. The bidder has to quote their prices in “price bid format in excel sheet” only as given on e-tender website. The price bid in PDF is strictly not to be submitted/uploaded
7. The bidder has also to upload the duly filled “PQR sheet in excel” on e-tender website
8. All the tender documents will be carried out only through E-tendering mode and the bidder has to submit all his tender documents (Like PQR Excel Sheet and Price Bid) in the e-tendering website.
9. Be ensured that all the required and supporting documents has to be uploaded on e-tender website.



## SUBMISSION OF BIDS

1. Bidder should log into the site well in advance for bid submission so that he / she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
2. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
3. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable.
4. Technical bid should not include any financial information. Technical bid containing financial information shall be declared non-responsive and shall be disqualified.
5. The offer/bid shall be submitted in two bid systems (i.e.) Technical bid and Price bid. The technical bid shall consist of all technical details along with commercial terms and conditions. Price bid shall be submitted as per the format provided in PDF.
6. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening.
7. Bidder should consider any addendum/corrigendum published on the tender document, on the relevant website, before submitting their bid.
